


BASIC FACTS & FIGURES:

NONPROFIT COMMUNITY HOSPITALS¹

- There are 2,919 private nonprofit community hospitals in the U.S., representing 59% of the total number of community hospitals and 77% of all privately owned community hospitals.
- State or local governments own 23% of the community hospitals, while private investors own 18%.

U.S. COMMUNITY HOSPITALS BY OWNERSHIP STATUS, 2006



• The distribution of beds by ownership status has remained stable over time. 70% of beds are private nonprofit, 16% government and 14% private for-profit. 84% of privately owned beds are nonprofit.

• Private nonprofit community hospitals tend to have a large number of beds (200+), state/local government hospitals have a small number of beds (<100), and private forprofit have a medium number of beds (50-199).

- Private nonprofit community hospitals tend to be more heavily represented in the Eastern, North Central, and Pacific states.
- State and local government community hospitals tend to be more heavily represented in some of the Southern, West North Central, Mountain, and Pacific states.
- Private for-profit community hospitals tend to be more heavily represented in the Southern and Mountain states.
